2.	Place of sitting & Jurisdiction of Permanent Lok Adalat.	1. Dehradun. 2. Haridwar 3. Nainital (Jurisdiction for the District Champawat also) 4. Udham Singh Nagar.
3.	Qualifications	A person who is, or has been, a district judge or additional district judge or has held judicial office higher in rank than that of a district judge, shall be the Chairman of the Permanent Lok Adalat. Preference shall be given to judicial officers who have served in the State of Uttarakhand.
4.	Age & Tenure	The Chairman shall hold office for a term of five years or till the age of 65 years, whichever is earlier.
5.	Sitting Fee & other allowances	Retired judicial officer shall be entitled to a monthly fee of last drawn salary less the amount of pension received by him/her. Apart from this, for the purpose of attending the sittings of Permanent Lok Adalat, the Chairman shall be entitled to conveyance allowance of Rs. 5,000/- per month.
6.	Last Date	Duly completed application form in the prescribed format with requisite annexures must be addressed to Member Secretary, Uttarakhand State Legal Services Authority, High Court Campus, Nainital-263001 and must reach by Speed Post/Registered Post/Courier/e-mail/By hand on or before <u>20th December, 2018 till 05:00 P.M.</u> <u>NOTE:</u> The envelope containing application form

		alongwith requisite annexures should be superscripted as: "Application for the post of Chairman, Permanent Lok Adalat" .
7.	Selection Procedure	By way of interview of eligible candidates by Hon'ble Executive Chairman, Uttarakhand State Legal Services Authority, Nainital or a committee nominated by him.
8.	Work of Permanent Lok Adalat	As per Section 22B of the Legal Services Authorities Act, 1987, Permanent Lok Adalat shall exercise such jurisdiction in respect of one or more public utility services as prescribed in sub-Section (b) of Section 22A of Legal Services Authorities Act, 1987 such as: <ul style="list-style-type: none"> i. transport service for the carriage of passengers or goods by air, road or water; or ii. postal, telegraph or telephone service; or iii. supply of power, light or water to the public by any establishment; or iv. system of public conservancy or sanitation; or v. service in hospital or dispensary; or vi. insurance service. vii. education or educational institutions; or viii. housing and real estate service.
9.	Others	Must attach certified photocopies of the following documents with the application form:- <ol style="list-style-type: none"> 1. Testimonials of age and all academic qualifications. 2. Last service record. 3. Last five years A.C.R. given by the employer. 4. Experience in public utility services.
