It is kindly submitted that in compliance of the direction of Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority, Nainital, mass legal literacy and awareness programmes and camps were organized in six districts of the State of Uttarakhand through Mobile Van of the Uttarakhand State Legal Services Authority from 11<sup>th</sup> October, 2023 to 19<sup>th</sup> October, 2023 and from 21<sup>st</sup> November, 2023 to 29<sup>th</sup> November, 2023.

For this purpose, an approved schedule of the Mobile Van Awareness Drive was circulated by the Uttarakhand State Legal Services Authority to the following districts:-

In order to ensure the effective implementation of the aforesaid Awareness Drive through Mobile Van, following directions were issued to the aforesaid Districts:-

- Concerning DLSAs are directed to display/broadcast the legal literacy and awareness based documentary films and other audiovideo informative materials to the general public during the mobile van visit.
- 2. Concerning DLSAs are directed to distribute the valuable legal informative booklets and other legal awareness literature only to the needy persons.
- 3. Necessary applications, forms, etc. for seeking legal aid, advice, and other beneficial schemes of the Central/State Govt. shall be filled up/prepared by the PLVs on the spot and thereafter the

- same shall be executed by the office of DLSA with the concerning departments.
- 4. Concerning DLSAs are directed to make aware the general masses about the functions and goal of the Legal Services Institutions and all the welfare schemes and policies being run by the National Legal Services Authority and Uttarakhand SLSA.
- Concerning DLSAs are directed to ensure the publicity of the Permanent Lok Adalats in coordination with the concerning Permanent Lok Adalats in addition to the other programmes during the said mobile van visits.
- **6.** Concerning DLSAs are directed to avail the services of Law Students for this purpose, wherever possible.
- **7.** Concerning DLSAs are directed to ensure wider and adequate publicity of the said campaign.
- 8. Concerning DLSAs are directed to coordinate with the District Administration, Police Administration, School Administration, concerned Gram Panchayats and Gram Pradhans, etc. for extending their cooperation in this regard.

In compliance of the aforesaid directions, concerning District Legal Services Authorities conducted mass legal literacy and awareness programmes and camps through Mobile Van in rural as well as in urban areas of their districts and also in schools.

On the basis of the statistical information furnished by the aforementioned District Legal Services Authorities relating to the said Mobile Van Drive, a consolidated report has been prepared and the same is hereunder:-

It is kindly submitted that as per the District-wise reports mentioned in the above table, it is found that during the aforesaid Mobile Van Awareness Drive, total 141 legal awareness programmes/camps organized in urban areas, rural areas and also in schools wherein around 210757 persons and students attended these legal awareness programmes/camps.
