
NOTIFICATION

In exercise of the powers conferred by Section 29A of the Legal Services Authorities Act, 1987 (Act No. 39 of 1987), the Uttarakhand State Legal Services Authority hereby makes the following regulations further to amend the Uttarakhand State Legal Services Authority (Transaction of Business and other Provisions) Regulations, 2006, namely:-

1. (1) These regulations shall be called the Uttarakhand State Legal Services Authority (Transaction of Business and Other Provisions) Amendment Regulations, 2017.
- (2) They shall come into force from the date of notification by State Authority.
2. In Para-13 of the Uttarakhand State Legal Services Authority (Transaction of Business and Other Provisions) Regulations, 2006, sub-Para-13.6 shall be included, namely:-

"The State Authority in consultation with the Chief Justice/Patron-In-Chief shall fix the quantum of fees to be paid to the Panel Lawyers for extending legal advice, aid and assistance to persons who are entitled to receive legal services as per the decision of the State or District Authority or High Court Legal Services Committee. Fee schedule adopted by the State Authority is given in Appendix - "A". As and when deemed fit and necessary, such fee schedule can be revised by the State Authority in consultation with the Chief Justice/Patron-In-Chief."
