## APPOINTMENT OF FULL TIME SECRETARIES IN DLSAs

In the month of April, 2018, two more full time Secretaries have been appointed in District Legal Services Authority, Champawat and Pithoragarh. Now, out of 13 DLSAs, in 11 DLSAs the full time Secretaries are working.

## NATIONAL LOK ADALAT

As per directions of National Legal Services Authority and under the valuable guidance of Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority, two National Lok Adalats were organized in the State of Uttarakhand from Tehsil Level to District Level in all the Courts and Quasi Judicial Authorities on 10.02.2018 and 22.04.2018 respectively. In these said National Lok Adalats, apart from the civil and criminal cases, the matters pertaining to labour disputes, revenue disputes, land acquisition act, family disputes, MACT, NI Act, water and electricity and all such matters which can be settled amicably were taken up.

In these National Lok Adalats, a total number of **19,039** cases were taken up and out of them **6022** cases were settled amicably. Amount to the tune of **Rs. 26,89,16,242/-** was also settled.

In order to propagate legal awareness among the common people about their legal rights, Government welfare schemes available to them and the legal activities being run by the legal services institutions, the Uttarakhand State Legal Services Authority first identified common problems of people at large in cluster of villages/places in the districts and then organized **49** Mega Legal Literacy and Awareness Camps thereon in coordination with various Government Departments benefitting **56,603** people. The said camps were based on the NALSA's newly designed camp module focusing on upliftment and empowerment of tribal people, poverty alleviation and public awareness, empowerment of labourers of unorganized sector, women and child welfare & protection, right of education, rights of senior citizens as well as introduction and implementation of various public welfare schemes.

Some of the camps were presided by the Hon'ble Executive Chairman, Uttarakhand SLISA and various authorities from different department sensitized the common people about the welfare schemes and also they were also provided the benefits on the spot. In these mega camps, District Administration also issued the Aadhar cards, disability certificate, pension certificates to the Widows and Old age Persons. The medical check-up was done on the spot and free medical and subsidized agriculture equipments were also distributed to the needy

people. The applications received during the camps with regard to the grievances and welfare requests were also forwarded to the departments concerned for appropriate action.

## TRAINING TO THE PANEL LAWYERS

To enhance the working skills and for ensuring accountability of panel lawyers towards the works assigned to them, the Uttarakhand State Legal Services Authority had conducted training programmes as per the second training module approved by NALSA in eight phases for the districts

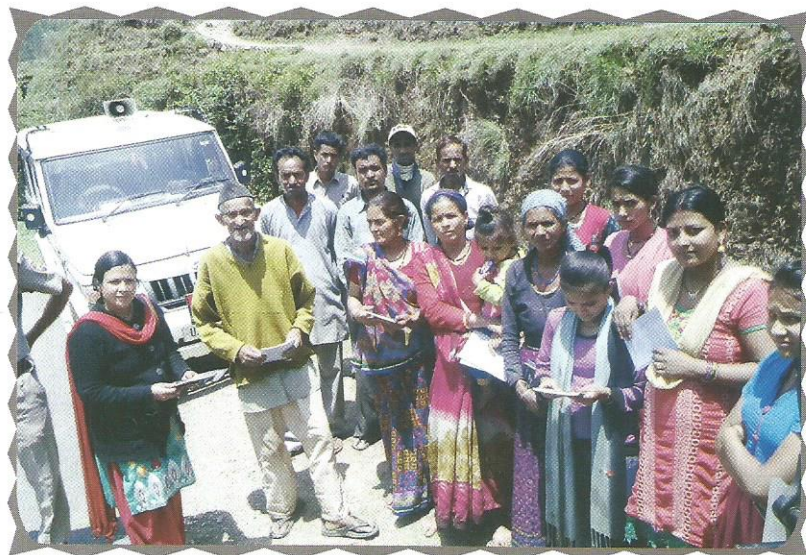
## LEGAL AWARENESS CAMPAIGN THROUGH MOBILE VAN

To provide legal aid and advice to the common people at their doorsteps, legal awareness and sensitization camps are being organized through mobile van throughout the State for cluster of villages in different districts. During the months of January, 2018 to June, 2018, State Legal Services Authority's mobile van visited District-Dehradun, Bageshwar and Uttarkashi covering **55** places whereby **22,151** persons were benefited. During the mobile lok adalat, **47** cases were taken up, out of which **18** cases were settled and amount of **Rs. 2,85,150/-** was also settled.

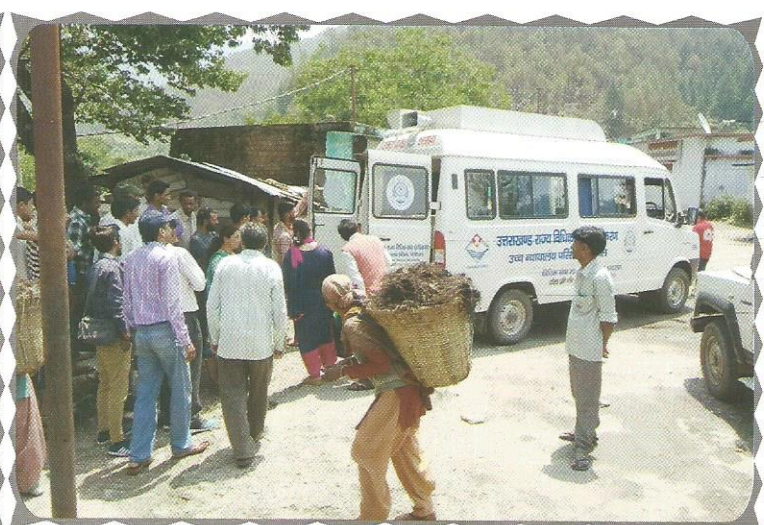

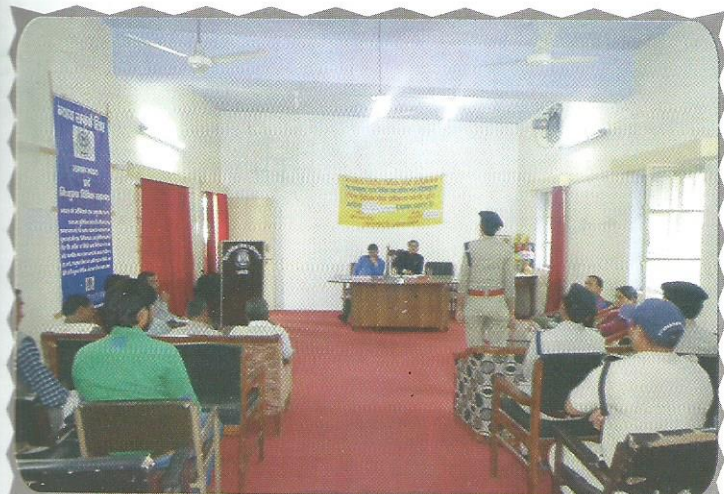
