

HISTORICAL PERSPECTIVE

rticle - 39A of the Constitution of India speaks for Equal Justice and Free Legal Aid. It states that "The State shall secure that the operation of the legal system promotes justice, on a basis of equal opportunity, and shall, in particular, provide free legal aid, by suitable legislation or schemes or in any other way, to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or other disabilities."

o fulfill this mandate of Article 39-A of the Constitution and establishing a nation-wide network for providing free and comprehensive legal services to the weaker sections of the society and also to secure and promote the philosophy of justice to all, the Legal Services Authorities Act was enacted in the year 1987. Thereafter, to make policy and implement the motto of "ACCESS TO JUSTICE FOR ALL", the National Legal Services Authority, Supreme Court Legal Services Committee, State Legal Services Authority, High Court Legal Services Committee, District Legal Services Authority and Tehsil Legal Services Committee have been established.

he Uttarakhand State Legal Services Authority was constituted on March 20, 2002 under Section 6 of the Legal Services Authorities Act, 1987 and its office was inaugurated at Nainital on 8th June, 2002 by Hon'ble Mr. Justice B.N. Kirpal, the then Chief Justice, Supreme Court of India in the august presence of Shri Arun Jaitley, Hon'ble the then Law Minister, Govt. of India.

AN OVERVIEW OF THE LEGAL AID MECHANISM OF THIS AUTHORITY I - FUNCTIONS

- To provide free legal aid & service of free Advocates to the eligible masses.
- To organise Lok Adalats for providing the efficacious, inexpensive and expeditious justice to all.
- To give a fertile focus to the policies of Central Authority (NALSA) under the joint auspices of High Court Legal Services Committee, District Legal Services Authorities & Tehsil Legal Services Committees.
- To augment the wide legal awareness amongst the flouted public at large specially the people living
 in the far-flung hill areas of the State through Legal Literacy & legal aid camps and make them aware
 about their rights and duties.
- To ensure that motto "Access to Justice for All" is made accessible to the poor and oblivious masses at their door-step.
- To organize Symposiums, Seminars and Conferences in order to settle disputes as well as to make the people aware about legal system.

II - ENTITLEMENT FOR FREE LEGAL SERVICES

Every person who has to file or defend a case shall be entitled to free legal services from State Legal Services Authority, High Court Legal Services Committee, District Legal Services Authority or Tehsil Legal Services Committee as the case may be, under the Section-12 of the Legal Services Authorities Act, 1987 & Rule-16 of the Uttaranchal State Legal Services Authority Rules, 2006., if that person is-

- A member of Scheduled Caste or Scheduled Tribe;
- A victim of trafficking in human beings or beggar as referred to in Article 23 of the Constitution:
- c. A woman or a child:
- a. A mentally ill or otherwise disable person:
- b. A person under circumstances of undeserved want such as being a victim of a mass disaster, ethnic violence, caste atrocity, flood, drought, earthquake or industrial disaster;
- c. An industrial workman:
- d. In custody, including custody in a protective home within the meaning of clause (g) of section 2 of the Immoral Traffic (Prevention) Act, 1956, or in a juvenile home within the meaning of clause (i) of section 2 of the Juvenile Justice Act, 1986 in psychiatric hospital of psychiatric nursing home within the meaning of clause (g) of section 2 of the Mental Health Act, 1987;
- e. In receipt of annual income from all sources less than rupees 1,00,000/- or such other higher amount as may be prescribed by the State Government, if the case is before a court other than the Supreme Court; or
- f. Ex-service man;

III - HIGH COURT LEGAL SERVICES COMMITTEE

nder Section 8A of the Legal Services Authorities Act, 1987, the High Court Legal Services Committee has been constituted in the High Court of Uttarakhand at Nainital. The Committee is governed by a sitting judge of the High Court who functions as the Chairman and is to be nominated by the Chief Justice, presently Hon'ble Mr. Justice V.K. Bist, Judge, High Court of Uttarakhand has been nominated for the post. An officer of the Uttarakhand Higher Judicial Services discharges his functions as Secretary of the High Court Legal Services Committee and is to be nominated by the Chief Justice. The High Court Legal Services Committee works by organizing Legal Literacy Camps, holding Lok Adalats and such other legal activities/policies as may be formulated and required by the NALSA and the SLSA at the High Court level.

IV - DISTRICT LEGAL SERVICES AUTHORITIES

he State of Uttarakhand has constituted the District Legal Services Authorities in all the 13 districts of the State, under Section 9 of the Legal Services Authorities Act, 1987, to provide free legal aid, to organize Lok Adalats, Legal literacy camps and to implement the policies to secure the motto of "Access to Justice for All". The District Authority is under the direct supervision of the District judge who acts as the ex-officio Chairman and is appointed by virtue of post. The State Authority in consultation with the Chairman of the District Authority appoints a person belonging to the cadre of Civil Judge (Senior Division) or in his absence Chief Judicial Magistrate, as the case may be, as Secretary of the District Legal Services Authority.

V - TEHSIL LEGAL SERVICES COMMITTEE

nder Section 11A of the Legal Services Authorities Act, 1987, the Tehsil Legal Services Committee have been constituted in the State to provide free legal aid, organize Lok Adalats, Legal literacy camps at the Tehsil level and performs such other functions as the District Authority assigns to it under the Act. The Tehsil Committee works under the direct supervision and directions of the District Legal Services Authority. A junior most Judicial Officer posted in the Tehsil acts as Secretary of the Committee. In case no such Judicial Officer is posted or only one Judicial Officer is posted, Tehsildar of the concerned Tehsil works as Secretary of the Committee in addition to his own duties.

VI - INFORMATIVE LITERATURE

Department, Schools, Colleges etc.

INCOME CEILING LIMIT:-Recently, the income ceiling limit for availing free legal services in accordance with the Section 12 (h) of the Legal Services Authorities Act, 1987 has been enhanced to the tune of Rs. 1 lakh per annum in the Uttarakhand State by the State Government.

A sum of Rs. 4,08,74,265/- was awarded as compensation to the victims of Motor Accident and a fine in the tune of Rs 51,50,185/- was realized in the petty offences. Many family matters and Revenue matters were also decided amicably in this Mega Lok Adalat. Infact, this was the first grand Mega Lok Adalat since the inception of our State and the

establishment of State Legal Services Authority in the State.

Second, Mega Lok Adalat in the entire State of Uttarakhand was organized on 9.11.2010 wherein a record number of 28,644 cases of various natures were amicably and successfully decided. A sum of Rs. 3,91,96,370/- was awarded as compensation and a fine in the tune of Rs 58.38.989/- was realized.
