In the Lok Adalats held in the months of July, August and September in all the 13 districts, a total number of 14,081 cases were amicably settled and a sum of Rs. 2,15,31,296/- was awarded as compensation and a fine to the tune of Rs. 47,72,701/- was realized.

In addition to this, 26 legal literacy camps were organized in Districts Almora, Bageshwar, Champawat, Pauri Garhwal, Pithoragarh, Rudraprayag, Tehri Garhwal and Udham Singh Nagar during July to September 2011 which were attended by 16,203 persons.

between 2nd August 2011 and 23rd September 2011 in all the 13 districts, the matters relating to MACT cases, Matrimonial cases, Revenue cases, Excise cases, cases relating to N.I. Act etc. were taken up. In these Mega Lok Adalats, a total number of 8209 cases of various nature were amicably and successfully decided. A sum of Rs. 1,47,79,280/- was awarded as compensation to the victims of Motor Accident and a fine to the tune of Rs. 26,82,826/- was realized towards petty offences, where in a total number of 8,726 persons were benefited.

BUILDING PLAN FOR ALTERNATIVE DISPUTE REDRESSAL CENTRES IN THE STATE



Proposed Building Plan for "Nyay Sadan" at Different Places
of all District Head Quarters in Uttarakhand

Hon'ble High Court of Uttarakhand has passed a resolution on 15.10.2011 for setting up of an ADR Centre (Nyay Sadan) in all the district headquarters of the State as well as in the premises of Hon'ble High Court of Uttarakhand at Nainital. In this regard, the Uttarakhand State Legal Services Authority has prepared a proto-type of this building and the same has been sent to all the judgeships of the District Courts to take immediate and concrete steps for the construction of the said ADR Centres under the 13th Finance Commission grant. The said ADR Centre shall work as a multi-facility service centre for the public of the State where they will get the facility of Permanent Lok Adalat, Mediation Centre, SLSA/DLSAs Office(s) etc. under one roof.

MISCELLANEOUS

The Uttarakhand Police Head Quarter has requested to this authority for providing free legal aid booklets, namely "Saral Kanooni Gyan Mala" (Total 26,372 sets) for the police personnel working in the State and Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority has been pleased to approve the same.

INITIATIVE TOWARDS ALTERNATIVE DISPUTE REDRESSAL (ADR) MECHANISM IN THE STATE

The Uttarakhand State Legal Services Authority is inclined to spread awareness of ADR mechanism among the people living in the far flung areas of the State. In this connection, a schedule for organizing seminars at least twice in the financial year 2011-12 in all the 13 districts has been prepared and

intimation have been made to the Mediation & Conciliation Project Committee (MCPC) Supreme Court of India, the Delhi High Court Mediation Centre and the Mediation Centre High Court of Judicature at Allahabad for providing the services of the Experts in the field of Mediation in the proposed seminars.
