# LEGAL AWARENESS

On 28.02.2012, a conclave was held with the senior officers of the Police Department of the State of Uttarakhand in order to propagate the legal awareness in each and every corner of the State through the effective and cooperative hands of the police personnel.

On the said occasion, Hon'ble Mr. Justice Barin Ghosh, Chief Justice/Patron-In-Chief, Hon'ble Mr. Justice Tarun Agarwala, Senior Judge/Executive Chairman, Uttarakhand State Legal Services Authority, Sh. J.S. Pande, the then Director General of Police, Mr. R.S. Meena, the then DIG, Kumaon Region, Sh. Ram Singh Registrar General High Court of Uttarakhand and Sh. Prashant Joshi, the then Member Secretar Uttarakhand SLISA were present.



Hon'ble Mr. Justice Barin Ghosh, Chief Justice/Patron-In-Chief and Hon'ble Mr. Justice Tarun Agarwala, Senior Judge/Executive Chairman, Uttarakhand SLISA inaugurated the said event by providing a set of 34 books of Saral Kannuni Gyan Mala to Sh. J.S. Pande, the then DGP and Mr. R.S. Meena, the then DIG, Kumaon Region with their kind hands. With the motivation of Hon'ble the Chief Justice/Patron-In-Chief and under the valuable guidance of Hon'ble the Executive Chairman, Uttarakhand SLISA, a proposal for providing 26 thousands sets (34 book in a set) of Saral Kannuni Gyan Mala books to all the police personnel of the State of Uttarakhand was passed unanimously.

Pursuant to the aforesaid, 26,372 sets (34 books in a set) of Saral Kannuni Gyan Mala books were provided to the Police Headquarter, Dehradun on 03.03.2012 for distributing the same to all the police personnel of the State, so that the legal services mechanism may reach at the door-steps of the people who are living in remote and mountainous regions of the Uttarakhand State without any hindrance and cost.



# LEGAL AID AND LEGAL AWARENESS CAMPAIGN

At Government Inter College, Dhaun and at Lohaghat, DIET legal literacy & medical camps were organized by the District Legal Services Authority, Champawat on 22.1.2012 and 18.3.2012. In these camps, students as well as public at large have been made aware about their legal rights by the Judicial Officers as well as Government Advocates. Free check-ups were made and the patients were also provided medicines free of cost in the said the camp.

In order to create more awareness about the State Police Complaint Authority and the Uttarakhand State Legal Services Authority and also create awareness against the grave misconduct and harassment of the police personnel being faced by the general masses, an advertisement was published in daily newspapers Dainik Jagran and Amar Ujala on 28.02.2012 and 02.03.2012 respectively for the general masses.

## MEDIATION CENTRE/ALTERNATIVE DISPUTE RESOLUTION MECHANISM IN THE STATE

The Uttarakhand State Legal Services Authority is inclined to spread awareness of ADR mechanism among the people living in the far flung areas of the State. The foundation stone of ADR Centres at District-Hardwar and Udham Singh Nagar was laid by Hon'ble Mr. Justice Barin Ghosh/Patron-in-Chief, Uttarakhand State Legal Services Authority on 26.11.2011 and 17.12.2011 respectively. For the said purpose, a sum of Rs. 1,76,33,975/- and a sum of Rs. 1,30,36,975/- were granted to the District Legal Services Authority, Hardwar and Udham Singh Nagar respectively in the month of March, 2012 for constructing the ADR Centres in their respective districts. A sum of Rs. 1,00,00,000/- has also been granted to the Public Works Department, Construction Division, Nainital for constructing a multi-facility ADR Centre in the High Court premises on 23.03.2012.

## LOK ADALAT

At the District Headquarter Nainital, a Mega Lok Adalat was organized on 24.2.2012. In the said Mega Lok Adalats, 271 cases were successfully decided by imposing fine to the tune of Rs. 1,40,000/- and by awarding the compensation to the tune of Rs. 5,50,000/-.

With the motivation of Hon'ble Mr. Justice Barin Ghosh, Chief Justice/Patron-in-Chief, Uttarakhand State Legal Services Authority and under the valuable guidance of Hon'ble Mr. Justice Tarun Agarwala, Executive Chairman, Uttarakhand State Legal Services Authority has organized Mega Lok Adalats as well as monthly Lok Adalats in all the 13 districts of the State, under the aegis of all the District Legal Services Authorities.

In the said Megal Lok Adalats and monthly Lok Adalats held in the months of January, February and March 2012 in all the 13 districts, a total number of 9931 cases were amicably settled and a sum of Rs. 2,73,09,403/- was awarded as compensation and a fine to the tune of Rs. 58,62,507/- was realized.

A schedule for organizing Mega Lok Adalats, Seminars, Monthly Lok Adalats and Legal Literacy Camps at Hon'ble High Court and District Courts for the financial year 2012-13 has been prepared by the Uttarakhand State Legal Services Authorities and the same has been approved by Hon'ble the Chief Justice/Patron-In-Chief, Uttarakhand SLSA on 14.03.2012.
