#### APPOINTMENT OF NEW EXECUTIVE CHAIRMAN

The Hon'ble Mr. Justice Prafulla C. Pant, Senior Judge, High Court of Uttarakhand has assumed the charge of Executive Chairman, Uttarakhand State Legal Services Authority, Nainital w.e.f. 11.06.2013 in pursuance of the Notification No. 165(2)/XXXVI(1)/2013-184/2001-T.C.-II dated 11.06.2013.

#### NATURAL DISASTER IN UTTARAKHAND

The State of Uttarakhand is facing a bad experience in the form of heavy rainfall, landslide and cloudbursts. Out of the 13 districts, 7 districts have been severely affected by the said natural calamity.

With view to provide legal services to the victims of disaster, the State Authority has issued directions to all the District Legal Services Authorities of the State as regards rehabilitation and relief, such as food and drinking water, shelter, transportation, health, electricity, safety of affected persons specially women and children, clothing and other basic household items to the affected persons. Relevant Chapters of National Policy on Disaster Management, Scheme for Legal Services to Disaster Victims through Legal Services Authorities and the relevant Government orders have also been provided to the District Legal Services Authorities.

Pursuant to the aforesaid directions, State Authority received action taken/steps taken reports from the District Legal Services Authorities as regards the disaster management works in the affected areas.

The Core Groups comprising of Judicial Officers, Advocates, Medical Officers, Members of Local Bodies, Law Students, Social Workers and NGOs have been constituted by the District Legal Services Authorities. The members of Core Groups visited the relief camps and monitored the disaster management work closely. After getting the reports from the Core Groups and District Administration on disaster management works, necessary matters have been taken by the District Legal Services Authorities with the District Administration for providing immediate relief, such as food and drinking water, shelter, transportation, health, electricity, safety of affected persons specially women and children, clothing and other basic household item to the affected persons.

The victims have also been provided necessary legal aid and assistance for lodging of missing report at Police Station and for getting the insurance amount and compensation for the loss of life, cattle and property as per relevant Government orders.

The activities of District Legal Services Authorities for Disaster Victims are continuously going on and all efforts are still being made to provide all benefits of various schemes of Government and Scheme for Disaster Victims by National Legal Services Authority.

### DRAWING AND PAINTING COMPETITION ON THE DAY OF WORLD ENVIRONMENT DAY

The Uttarakhand State Legal Services Authority under the valuable guidance and motivation of Hon'ble Mr. Justice Prafulla C. Pant, Executive Chairman organized a drawing and painting competition on 5.6.2013 at Mohan Lal Sah Girls Inter College, Oak Park, Mallital, District-Nainital on the occasion of World Environment Day. Secretary, Uttarakhand State Legal Services Authority, Registrar General and Registrar (Judicial) and Registrar (Protocol) of High Court of Uttarakhand, Professors of Kumaon University, Nainital, Assistant Manager, Principal and Teachers of Mohan Lal Sah Girls Inter College, Principals/Teachers of other five colleges and students were also present.

In the aforesaid drawing and painting competition, 24 students in Junior Section (Class 6 to 8) and 24

students in Senior Section (Class 9 to 12) of six Government Girls Inter College and Inter Colleges participated. The topic for Junior Section was 'Water Conservation' and the topic for senior section was 'Food Conservation'. The topic for drawing and painting competition for Senior Section was based on the theme given by United Nation on the World Environment Day, 2013. The U.N.O. had given the theme of Food Conservation with a slogan of "Think.Eat.Save: Reduce your food print".

The school students both in Junior Section as well as Senior Section expressed their ideas and views on the subjects given in the form of drawing and painting. Awards were distributed to the winning three students from both the sections by the kind hands of Hon'ble Executive Chairman.

Hon'ble Mr. Justice Prafulla C. Pant informed the gathering about various issues relating to environment and the duty of every citizen to conserve the environment. Students were also sensitized for protection and conservation of environment, as they can play a vital role in making the environment pollution free. Hon'ble Mr. Justice Prafulla C. Pant made stress on the balance between development and environment. Focus was also made on the sustainable development.

Free booklets having basic legal information on various subjects, were also distributed to the teachers of all the aforesaid six colleges, so as to sensitize the students about their legal rights.

On the said occasion, Member Secretary, Uttarakhand State Legal Services Authority, Professor Lalit Tiwari from Kumaon University, Assistant Manager and Principal, Mohan Lal Sah Girls Inter College also expressed their views on the different issues relating to environment.

#### MEGALOK ADALATS, LOK ADALATS & LEGAL LITERACY/LEGAL AID CAMPS

Under the valuable guidance of Hon'ble the Patron-in-Chief and Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority, Mega Lok Adalats as well as monthly Lok Adalats are being organized in all the 13 districts of the State by all the District Legal Services Authorities.

In the 12 Mega Lok Adalats held between the months of April 2013 to June 2013 in all the 13 districts, the matters relating to MACT cases, Matrimonial cases, Revenue cases, Excise cases and cases relating to N.I. Act etc. were taken up. In these Mega Lok Adalats, a total number of 1855 cases of various nature were decided. A sum of Rs. 46,07,007/- was awarded as compensation to the victims of Motor Accident and fine to the tune of Rs. 10,34,235/- was realized towards petty offences, wherein a total number of 1907 persons were benefited.

In the 28 Lok Adalats held in the months of April, May and June 2013 in all the 13 districts, a total number of 2642 cases were settled and a sum of Rs. 1,43,71,590/- was awarded as compensation and a fine to the tune of Rs. 18,01,605/- was realized. In the said Lok Adalats, 2748 persons were benefited.

In addition to this, a total number of 31 legal literacy camps were organized in all the 13 Districts of the State during April to June 2013 and 4938 persons were benefited in the said camps. Total 113 persons were provided legal aid and 26 persons were given legal advice. In these camps, people were made aware about the aim of legal literacy camps, free legal aid and they were also informed about the general laws such as criminal law, revenue law, right to information act, right to education and law relating to protection of women, children etc.

Beside this, special seminars were organized for women, children, un-organized workers, health workers, NCC and NSS cadets, persons of transgender community, mentally ill persons and marginalized sections of the society. In these seminars, issues, such as PC&PNDT Act, Juvenile issues, laws relating to unorganized labours, forest laws etc. are discussed.

Special legal literacy and sensitization camps and seminars on issues pertaining to juveniles are being conducted for the Child Welfare Officers and Investigating Officers. In the said camps, Child Welfare Officers and Investigating Officers are being made aware about the provisions relating to Juvenile Justice Act and the procedures mentioned in the said Act. They are also informed about their duties while dealing with the matters relating to juveniles.

Special legal literacy and sensitization camps for women are also being organized for the welfare of women. In the said camps, they are informed about various subjects of law relating to them, such as Domestic Violence Act, Dowry Prohibition Act, PC&PNDT Act, Right to Education Act and the issues pertaining to their Legal Rights, Constitutional and Fundamental Rights, Maintenance, Child Marriage.

In addition to this, special seminars on the subjects PC&PNDT are also being organized, so as to make awareness about the provisions and procedures as contained in the PC&PNDT Act. The concerning issues, such as decreasing sex ratio and female foeticide and its adverse effect to the society have also been explained to the people at large.

### **ACTIVITIES ON LEGAL LITERACY AND AWARENESS PROGRAMMES**

District Legal Services Authority, Almora organized a legal literacy and sensitization camp at District Jail, Almora on 12.5.2013. In the said camp, prisoners were informed about their legal rights. Emphasis has been made on the establishment of Legal Aid Clinic at the Jail premise so as to provide necessary legal aid to the prisoners. The problems of the under-trial prisoners were also solved. The Jail Superintendent informed the prisoners about the welfare schemes being run by the Legal Services Authorities.

On 20.5.2113 District Legal Services Authority, Almora organized a legal literacy and sensitization camp at Government Girls Juvenile Home. In the said camp, the problems of the female inmates were heard and assurance was made to resolve their problems. The female inmates were also informed about various issues of laws. Books of Saral Kanooni Gyan Mala series were also distributed.

District Legal Services Authority, Almora conducted a mega legal literacy and sensitization camp on 2.6.2013 at Sumitra Nandan Pant Primary School, Chani, Kaushani. In the said camp, gathering was informed about the entitlement for availing free legal aid, lok adalat, mediation and laws relating to human right, dowry, child marriage, right to information and the rights of labourers.

District Legal Services Authority, Bageshwar organized a special training camp on the issues relating to juveniles on 20.4.2013 at Tehsil Compound, Bageshwar. In the said training camp, Child Welfare Officers and Investigating Officers were present. They were informed about the provisions of Juvenile Justice Act and the procedures contained therein. They were also informed that the directions issued by Hon'ble Supreme Court should be complied with while investigating the cases relating to juveniles. The offences relating to juveniles were also discussed.

On 31.5.2013, District Legal Services Authority, Bageshwar conducted a legal literacy and sensitization camp for under-trial prisoners and other prisoners at Joint District Jail-of Almora & Bageshwar. In the said camp, prisoners were informed about the provisions pertaining to bail and remand. They were also informed about the scheme of free legal aid being run by the Legal Services Authorities for the welfare of the under-trial prisoners.












District Legal Services Authority, Bageshwar organized a special legal literacy and sensitization camp for workers of tea garden on 19.5.2013. In the said camp, provisions relating to Factory Act, 1948, Employees Provident Fund Act 1948 and Minimum Wages Act were informed to the people. Labourers were also asked to approach Legal Services Authority for necessary legal aid.





District Legal Services Authority, Bageshwar in coordination with the PC&PNDT Cell conducted a legal literacy and sensitization camp on 23.6.2013 at the Hall of office of Chief Medical Officer. In the said camp, doctors, health workers and other females were present. In the said camp, the provisions and issues relating to PC&PNDT were informed to the gathering. Concern has also been made on the decreasing sex ratio and its adverse effects in future.

On 26.5.2013 District Legal Services Authority, Champawat organized a legal literacy, awareness and medical camp at Government Inter College, Dayartoli. In the said camp people were asked to abide by the law and they were informed about the objects of legal literacy and legal aid programmes and the free legal services being provided to the poor and needy persons. Information was also provided by the Judicial Officers and Advocates to the gathering on various subjects of laws, such as consumers laws, motor accidents laws, Right to Information Act, Right to Education Act and provisions relating to dowry matters. In the said camp, 300 persons were present. On the said occasion, medical camp was also conducted by the Medical Department and medicines were also distributed to the patients.



On 19.5.2013 District Legal Services Authority, Champawat also organized a special micro-legal camp on the issues pertaining to PC&PNDT Act at Kimtoli Pulla Hindola. In the said camp, Judicial Officers, Advocates and representative of Mahila Samakhya were present. In the said camp, focus was made on the women empowerment and people were informed about the various provisions of PC&PNDT Act and about their constitutional rights and fundamental rights. People were also informed that determination of sex of a child before birth is illegal under the law.

District Legal Services Authority, Dehradun conducted a legal literacy and awareness camp at District Jail-Siddowala on 27.4.2013. The Judicial Officers informed the prisoners that the necessary legal aid and advocates for defending the cases are being provided to the under-trial prisoners by the legal services authorities. The procedure for availing the legal aid has also been informed to the under-trial prisoners. Necessary legal aid was provided to the under-trial prisoners and efforts were also made to solve their problems.









On 26.4.2013 Libra College of Law, Dehradun organized a special camp on Anti Ragging. In the said camp, all students and college authorities participated. The students were made aware about the provisions of anti ragging act and they were also told that the ragging pollutes the environment of the educational institutions. A drama was also organized on the subject of Anti Ragging.

On 26.5.2013 District Legal Services Authority, Haridwar organized a legal literacy, awareness and sensitization camp at Primary School, Village-Podowali. In the said camp, people were made aware of several subjects, such as free legal aid, women rights, rights of labourers, lok adalat, mediation centre etc. A total number of 250 persons were benefitted in the said camp.

On 30.6.2013 District Legal Services Authority, Haridwar conducted a legal literacy and awareness camp

was conducted at Panchayat Bhawan, Tehsil-Roorkee. In the said camp, people were informed about lok adalat, mediation, provisions relating to lodging of F.I.R., Revenue Laws, Mutation etc. A total of 523 persons were benefitted.

District Legal Services Authority, Haridwar conducted a special legal literacy and legal aid camp on 30.6.2013 at Railway Station, Haridwar for the disaster affected victims. Affected persons were informed about lodging of the missing report, necessary documents for compensation and L.I.C. claims and 166 persons were benefitted in the said camp.

The District Legal Services Authority, Nainital in association with National Cadet Corps installed stalls on 14.5.2013, 24.5.2013 and 27.5.2013 at Mallital. The persons who visited the stalls, were informed about the objects for conducting legal aid programmes by the legal services authorities. Legal informative books were also distributed to the people free of cost.

District Legal Services Authority, Nainital conducted a legal literacy and sensitization camp at Pt. Poornanand Government Inter College, Dhanachuli, Nainital in the month of May, wherein 150 sets of saral kanooni gyan mala booklets were distributed and 150 persons were benefitted.

On 21.4.2013 District Legal Services Authority, Pauri Garhwal organized a legal literacy and medical camp at Government Inter College, Kanwaghati Kishanpuri, Kotdwar wherein people were informed about mediation

and lok adalats. Provision of various legal subjects relating to Family disputes, M.A.C.T. Act, Right to Information, laws relating to landlord and tenant, Revenue, Consumers, Forest and Panchayat Raj were informed to the people. In the said camp, 400 persons were benefitted. Free medicines were also distributed to the patients.













District Legal Services Authority, Pauri Garhwal conducted a legal literacy and sensitization camp on 26.5.2013 at the compound of Gramin Kshetra Vikas Samiti, Ranichauri on the subject PC&PNDT Act. In the said camp, gathering was informed about the provisions of PC&PNDT Act. Concern has been made on the abnormal sex radio between male and female and on the female foeticide. Appeal was made to be aware about the female foeticide and its drawbacks. A documentary relating to PC&PNDT Act was also displayed in the said camp. Total 155 persons were benefitted.

On 4.4.2013, District Legal Services Authority, Pithoragarh conducted a training camp for the Child Welfare Officers and Investigating Officers. In the said training camp, Child Welfare Officers and Investigating Officers were informed about the Juvenile Justice Act and its provisions. They were also informed about their duties. The questions raised by them were also duly answered.

District Legal Services Authority, Pithoragarh organized a legal literacy and sensitization camp at Judicial Lockup, Pithorgarh on 29.4.2013. In the said camp, 44 under-trial prisoners were present. They were informed about their legal rights and the provisions of forest laws and wildlife act and the legal aid being provided by the Legal Services Authorities to the under trial prisoners.

On 11.5.2013 District Legal Services Authority, Pithoragarh organized a special training camp for the Child Welfare Officers and Investigating Officers at District Court compound. In the said training camp, Child Welfare Officers and Investigating Officers were informed about the provisions and procedures pertaining to Juvenile Justice Act. They were also informed about their duties while investing the matters relating to juveniles. The queries made by the Child Welfare Officers and Investigating Officers on the said subject were also duly answered.

District Legal Services Authority, Pithorgarh organized a legal literacy and sensitization camp on 19.5.2013 at Government Inter College, Ganai Gangoli, Tehsil -Gangolihat. In the said camp, other government departments also installed their stalls. The Judicial Officers, Advocates, officers of District Administration, Doctors, Principal,

Teachers, School Officials and Social Workers were present. In the said camp, gathering was made aware of lok adalat, mediation and free legal aid and programmes of the legal services authorities. Information was also

provided on various provisions of law, such as M.A.C.T. Act, Labour Laws, Domestic Violence Act, Juvenile Justice Act, Forest Act, PC&PNDT Act, Right to Information Act, Revenue Act, Wildlife Conservation Act and Laws relating to children and matrimonial and dowry matters and the procedure of lodging of F.I.R., Arrest and Bail. In the said camp, 400 persons were benefitted. Free distribution of pamphlets containing information about legal aid programmes were also made.

Information was given about the National Rural Health Mission. Free check ups of 113 persons was also done in the said camp. The Revenue Department issued permanent resident certificates, Scheduled Caste/Scheduled Tribe certificates, Character Certificates, Income Certificates and Hill Certificates to the people. Social Welfare Department received applications regarding

Income Certificates and Hill Certificates to the people. Social Welfare Department received applications regarding Pensions to Senior citizen, widows and handicapped persons. Forest Department informed the people about various provisions relating to Forest Laws. The Animal Husbandry Department also distributed medicines free of cost. The Village Development Department informed the people about various welfare schemes run by State Government. Copies of the 90 Family Register and 15 B.P.L. certificates were also issued to the needy persons. The Agriculture Department also informed about the various schemes made by the State Government for the welfare of the people. The officers of Child Development Project (I.C.D.S.) also informed about Aandadevi Kanyadhan and the objects of Bal Vikas Sewa.

On 22.5.2013, District Legal Services Authority, Pithoragarh organized a legal literacy camp at Judicial Lockup, Pithoragarh. In the said camps 33 under-trial prisoners were present. They were informed about the procedures pertaining to Cr.P.C., arrest and bail, their legal rights, plea bargaining and the legal aid being provided by the Legal Services Authorities to the under-trial prisoners.

District Legal Services Authority, Pithoragarh conducted a seminar on PNDT Act. In the said seminar, medical officers, health workers, aanganbadi workers and other ladies were present. Gathering was informed that female foeticide is the cause of decreasing sex ratio. They were asked to make efforts for sensitizing the other persons, so that the female foeticide may be stopped.

On the occasion of 'World Labour Day', District Legal Services Authority, Pithoragarh organized a legal literacy and awareness camp at District Court Compound on 12.6.2013. In the said camp labourers

were made about their legal rights. Various provisions of laws relating to labourers were also informed to the labourers in simple language.

On the occasion of 'Anti Tobacco Day' District Legal Services Authority, Rudraprayag organized a seminar on 31.5.2013 at Nagar Palika Hall, Rudraprayag. In the said seminar, Judicial Officers, officers and officials of Nagar Palika were present.

People were informed about the ill effects caused by the use of tobacco. They were also informed about the provisions relating to N.D.P.S. Act and Tobacco Substances Act.

District Legal Services Authority, Rudraprayag conducted a legal literacy and sensitization camp on 16.6.2013 at Vikas Khand-Jakholi. In the said camp, Judicial Officers, representatives of district administration and other people were present. People were informed about their constitutional rights and the provisions relating to Legal Services Authorities Act, 1987, Right to Information Act and M.A.C.T. A total number of 100 persons were benefitted in the said camp.

On 26.5.2013, District Legal Services Authority, Tehri Garhwal conducted a legal literacy camp on the subject PNDT at Vikas Samiti Bhawan-Ranichauri. In the said camp, Judicial Officers, District Administration and Medical Officers were present. Concern was expressed on the decreasing ratio of females. Gathering was also informed about the provisions of PNDT Act and were asked to come forward to stop the female foeticide. Documentary on subject of PNDT was also displayed to the people by the Health Department.









District Legal Services Authority, Tehri Garhwal organized a legal literacy and sensitization camp at District Jail-New Tehri. In the said camp, staff of the District Jail, under-trial prisoners and other prisoners were present. They were informed about the laws relating to plea bargaining, parole, cognizable and non-cognizable offences, bail, remand, procedure of Cr.P.C. and the legal aid being provided to the under-prisoners by the Legal Services Authorities in the State.

On the occasion of 'Anti Tobacco Day', District Legal Services Authority, Tehri Garhwal conducted a sensitization camp on 31.5.2013, wherein pamphlets relating to the said issues were distributed among the people.

On 28.4.2013 Uttarakhand State Legal Services Authority, Uttarkashi organized a legal literacy and sensitization camp at V.R.O. Camps, Tekhla Patti, Tehsil-Bhatwadi. In the said camp people were informed about various provisions of law relating to lodging of F.I.R., M.A.C.T. Forest Laws, Consumers, Compensation and Right to information. Legal informative booklets were also distributed on the said occasion. Total 200 persons were benefitted in the said camp.

District Legal Services Authority, Uttarkashi organized a special seminar for labourers on the day of 'International Labour Day' at District Court compound. In the said seminar, judicial officers, advocates, litigants, officials of district judgeship and labourer from both organized and unorganized sections were present. Labourers were informed that various laws have been enacted for the welfare of labourers and for the protection of their legal rights. They were also asked to approach the appropriate legal forum for protecting their legal rights.

On 31.5.2013 District Legal Services Authority, Uttarkashi organized a seminar on the day of 'World Anti Tobacco Day' at District Court compound. In the said camp, Judicial Officers, Advocates, Litigants and officials of the Uttarkashi Judgeship were present. In the said seminar, people were informed about the ill effects of tobacco and smoking.

### LEGAL AWARENESS CAMPAIGN THROUGH MOBILE VAN

Monthly legal awareness and sensitization camps are being organized through mobile van. In the months of April, May and June, 2013, the said mobile van went to 95 villages of the four districts, namely Hardwar, Uttarkashi, Tehri Garhwal and Almora. A total 3644 kilometers of area was covered by the said mobile van. In the said camps documentary films prepared by National Legal Services Authority and State Legal Services Authority were displayed so as to make the public aware about their legal rights and duties. Also various legal provisions of social importance were also informed to the people. The queries raised by the villagers were also solved in these legal awareness and sensitization camps.

In these camps, a total number of 9241 persons were benefitted. The applications received in the legal awareness and sensitization camps through mobile for legal aid were either disposed of at the level of State Authority or were sent to the authorities concerned for appropriate and necessary action.

















#### COMPLAINT BOXES

Complaint boxes are being installed in the legal aid clinics of Law Colleges. One complaint box is being installed at the law college and two are being installed in the villages adjoining law college. Installation of complaint boxes in the aforesaid law colleges will cover a large area of the State.

The Principal or the teacher has be requested to take suitable steps on the complaints so received by either directing them to the concerned District Legal Services Authorities or to the State Legal Services Authority as the nature of the complaint may require.


