

NATIONAL LOK ADALAT



As per directions of National Legal Services Authority and Hon'ble the Patron-in-Chief, a Natonal Lok Adalat was organized from Tehsil Level to High Court Level at all the Courts and Quasi Judicial Authorities throughout the State of Uttarakhand on 23.11.2013. In the said National





Lok Adalat, apart from the civil and criminal cases, the matters pertaining to labour disputes, revenue disputes, land acquisition act, MNREGS disputes, disaster compensation, water and electricity and all such matters which can be disposed of by way of settlement were taken up.





Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority and Hon'ble Chairperson, High Court Legal Services Authority made their benign presence in the Inaugural Session of the National Lok Adalat. In order to make the National Lok Adalat a success, necessary

directions and guidelines were also issued to the advocates, representatives of Insurance Companies and the litigants. During the occasion, Registrar General of the Hon'ble High Court, Member Secretary, Uttarakhand State Legal Services Authority and the other Registrars of the High Court were also present.

A total number of 55,122 cases were listed in the National Lok Adalat. Out of the said cases, 26,394 cases were disposed off through amicable settlement. Compensation to the tune of ₹5,48,01,611/- was awarded and ₹69,91,443/- was realized as fine. In the said camp 27,557 persons of different sections of society were also benefited.

As on 31.12.2013 the total pendency at High Court was 20686 and at the subordinate Courts was 152654. With the disposal of 26394 cases in the National Lok Adalat, the Uttarakhand State has achieved about 13.21 percent of reduction in the total pendency of the State.

MEGA LOK ADALATS, LOK ADALATS & LEGAL LITERACY/LEGAL AID CAMPS

Under the valuable guidance of Hon'ble the Patron-in-Chief and Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority, Mega Lok Adalats as well as monthly Lok Adalats in all the 13 districts of the State, under the aegis of all the District Legal Services Authorities, are being organized.

MEGA LOK ADALAT



In the Mega Lok Adalats held between the months of October 2013 and December 2013, the matters relating to MACT cases, Matrimonial cases, Revenue cases, Excise cases and cases relating to N.I. Act etc. were listed. In these Mega Lok Adalats, a total number of 903 cases of various nature were taken up and 210 cases were decided. A sum of ₹ 3,50,000/- was awarded as compensation to the victims of Motor Accident and fine to the tune of ₹ 7,18,355/- was realized towards petty offences, wherein a total number of 187 persons were benefited.

LOKADALAT

In the Lok Adalats held in the months of October, November and December, 2013 in all the 13 districts, a total number of 12,284 cases were taken up and 4,960 cases were settled. A sum of ₹ 19,25,164/- was awarded as compensation and a fine to the tune of ₹ 12,92,577/- was realized. In the said Lok Adalats, 5,003 persons were benefited.

In addition to this, a total number of 59 legal literacy camps were organized in all the 13 Districts of the State during October to December 2013 and 28,142 persons were benefited in the said camps. Total 130 persons were provided legal aid and 09 persons were given legal advice. In these camps, people were made aware about the aim of legal literacy camps, free legal aid and they were also informed about the general laws such as criminal law, revenue law, right to information act, right to education and law relating to protection of women, children etc.

Beside this, special seminars were organized for women, children, un-organized workers, health workers, NCC and NSS cadets, persons of transgender community, mentally ill persons and marginalized sections of the society. In these seminars, issues, such as PC&PNDT Act, Juvenile issues, laws relating to unorganized labours, forest laws etc. are discussed.

ACTIVITIES ON LEGAL LITERACY AND AWARENESS



During the Dushhera Festival, District Legal Services Authority, Almora put up legal literacy and sensitization stalls at Main Market, Almora and at Ramsey Inter College, Almora on 14.10.2013. In the said stalls, people were informed about their legal rights. Saral Kanooni Gyan Mala booklets containing legal informative material were also distributed.



District Legal Services Authority, Almora put up a stall from 7.11.2013 to 13.11.2013 at the premises of Saradotswa Mela. A large number of people visited the stall and were benefitted. A total number of 7000 Saral Kanooni Gyan Mala booklets were also distributed among the people.

On 9.11.2013, 16.11.2013 and 17.11.2013 District Legal Services Authority, Almora conducted legal literacy and sensitization camps at Government Girls Inter College, Someshwar, Primary School, Shyalidhar and Government Intermediate College, Dinapani. In the said camps, Judicial Officers, Teachers and students were present. They were apprised of their legal rights as well as the activities and programmes being run by the Legal Services Authorities for the poor and weaker



section of the society. They were also made aware of the laws relating to Forest, Animal Cruelty, Motor Vehicle etc. A total 6050 students were benefited.

On 27.10.2013 District Legal Services Authority, Bageshwar conducted a special camp for the workers at Jhiroli Magnesite Factory, Jhiroli. In the said camp, Judicial Officer, Management of the Company, representatives of Worker's Union and 450 workmen were present. They were made aware about their legal rights and facilities admissible to them as per law and the provisions relating to labour laws.

District Legal Services Authority, Bageshwar organized a special camp on the occasion of 'Children Day' on 16.11.2013 at Maharshi Vidhya Mandir, Bilona. In the said camp, Judicial Officers, Members of Bar Association, Advocates, Teachers and Students were present. Students were informed about their legal rights, Child Marriage Act, Right to Education Act, Copying Act, Motor Vehicle Act and Child Labour Act. A total 450 students were benefited.

On 18.12.2013 District Legal Services Authority, Bageshwar organized a legal literacy camp at Joint District Jail, Almora/Bageshwar. In the said camp, under-trial prisoners were informed about their legal rights and the free legal aid being provided to them by the Legal Services Authorities. They were also made aware about the procedure for arrest and parole. A total 42 prisoners were benefited.

District Legal Services Authority, Chamoli conducted a legal literacy and medical camp at Government Inter College, Vikasnagar (Ghat) on 20.10.2013. In the said camp, people were informed about the need to organize legal literacy and sensitization camps. The programmes and activities being carried out by the Legal Services Institutions in the State were also informed to the people and they were made aware of their legal rights and the laws relating to PC&PNDT Act, Domestic Violence Act, Wild Life Act, M.A.C.T Act. In the said camp, medical check up of 148 persons was done and they were also distributed medicines free of cost.

On 22.12.2013 District Legal Services Authority, Chamoli organized a legal literacy camp at Government Intermediate College, Joshimath. In the said camp, people were informed about the objects for conducting legal awareness camps and programmes/activities of Legal Services Authorities. They were also sensitized about the provisions pertaining to PC&PNDT Act. Need for spreading awareness against adverse sex ratio and female foeticide was also expressed. Beside this, information on the subjects, such as Domestic Violence, Women Right, Dowry, Wildlife, Animal Cruelty, Compensation, Motor Accident Claims and Child Right were also given to the people.

District Legal Services Authority, Champawat organized a legal literacy and sensitization camp on 16.10.2013 at Government Primary School, Khidi. In the said camp, information pertaining to various subjects of law including women rights and PC& PNDT Act was provided to the gathering. In the said camp, 68 persons were benefited.

District Legal Services Authority, Champawat organized a legal literacy and sensitization camp on 16.11.2013 at Government Higher Secondary School, Aambagh. In the said camp, students were apprised about the provisions pertaining to Motor Vehicle Act, Forest Laws, Constitutional Rights and Duties and Right to Education Act. A total 267 persons were benefited.

On 17.11.2013 District Legal Services Authority, Champawat conducted a sensitization camp for children at Senior Secondary School, Swala wherein the students were apprised of basic laws and their legal rights.

On 1.12.2013 District Legal Services Authority, Champawat organized a legal literacy and sensitization camp on the subject 'Health Security and H.I.V.' at Government Hospital, Tanakpur. People were informed about the disease H.I.V., its symptoms and precaution.

On International Day of Persons with Disabilities i.e. 3.12.2013 District Legal Services Authority, Champawat conducted a special legal literacy camp for disabled persons wherein they were informed about welfare schemes being run by the State Government and the necessary certificates were also issued to them.

On 26.10.2013 D.A.V. (P.G.) College, Dehradun in association with District Legal Services Authority, Dehradun organized a legal literacy camp on Anti Ragging. In the said camp, students were sensitized about the issues relating to Anti Ragging Law. A drama, namely 'Chetna' was also played by the students on the subject.

The District Legal Services Authority, Dehradun conducted a special camp for children at D.A.V. Inter College on 16.11.2013 and 17.11.2013. In the said camp, students were made aware about various laws relating to them.









On 30.11.2013 District Legal Services Authority, Dehradun conducted a jail camp wherein information on provisions relating to Code of Criminal Procedure was provided to the under-trial prisoners.

On 19.12.2013 District Legal Services Authority, Dehradun organized a seminar on the issues pertaining to PC&PNDT Act at the premises of office of Chief Medical Officer, Dehradun. In the said camp, Judicial Officers, Doctors and Medical Staff were present. They were informed about the provisions relating to PC&PNDT Act. Concern was also made on adverse sex ratio, early sex determination and female foeticide.

Apart from this, legal literacy classes in coordination with the District Legal Services Authority, Dehradun are being conducted at various Government Intermediate Colleges of District-Dehradun. In the said classes, students are made aware about the issues pertaining to pollution, environment, forestation, constitutional rights and duties etc.

On 27.10.2013, District Legal Services Authority, Haridwar conducted legal literacy and sensitization camps at Shahid Smarak Sunhera, Tehsil-Roorkee and at Primary School, Sethpur. In the said camps 460 people were present. They were informed about mediation, free legal aid, pre-litigation lok adalat and the provisions pertaining to Right to Education, Right to Information, Motor Vehicle Act and Revenue Laws.

District Legal Services Authority, Haridwar conducted a legal literacy and sensitization camp on 16.11.2013 at Government Primary School, Roshnabad wherein students were informed about general knowledge, physical and mental development and labour laws. A total 360 students were benefited.

The District Legal Services Authority, Nainital put up a legal literacy stall at Saroli Gramin Himalaya Haat Mela from 17.10.2013 to 21.10.2013. In the said stall, people were informed about their legal rights. A total number of 29140 booklets, namely Saral Kanooni Gyan Mala and application forms for availing free legal aid were distributed among the people. The documentary films prepared by State Authority on mediation, lok adalat and legal aid were also shown to the people.







The District Legal Services Authority, Pauri Garhwal conducted a legal literacy and sensitization camp at Government Intermediate College, Laxmanjhula on 13.10.2013. In the said camp, gathering was informed about the provisions of Consumer Laws, Right to Information, Protection of Children from Sexual Offences Act, 2012, M.A.C.T., Revenue Laws and Right to Education. A total 400 persons were benefited.

On 16.11.2013 District Legal Services Authority, Pauri Garhwal organized a legal literacy and sensitization camp at Government Inter College, Pauri City wherein people were informed about Consumer Laws, Right to Education, Protection of Children from Sexual Offences Act, 2012 and Right to Education. A total 400 persons were benefited.

On 6.10.2013 the District Legal Services Authority, Pithoragarh conducted a legal literacy and sensitization camp at Dasaithal, Tehsil-Gangolihat. In the said camp, the Medical Department, Revenue Department, Horticulture Department, Social Welfare Department and Forest Department also installed their stalls. People were informed about various provisions of law pertaining to Motor Vehicle Act, Labour Laws, Protection of Women from Domestic Violence Act, Child Labour Laws, Juvenile Justice Act, Right to Information Act, Right to Education Act, PC&PNDT Act, Forest & Wildlife Laws and the welfare schemes being run by various departments of the State Government. In the said camp, 200 persons were benefited.

The District Legal Services Authority, Pithoragarh organized a seminar on the occasion of 'World Mental Health Day' on 10.10.2013 at District Court Compound, Pithoragarh. In the said seminar, Judicial Officers, Advocates, Doctors, public representatives and police officials were present and discussion was held on the issues relating to Mental Health and a need to help the mentally disabled persons was also expressed.

On 9.11.2013 District Legal Services Authority, Pithoragarh conducted a legal literacy class at Government Intermediate College, Pithoragarh. In the said camp, students were made aware of various subjects of law, such as Right to Education, Labour Laws, Right to Information, Consumers Laws, PC&PNDTAct, Domestic Violence Act, Dowry Act and Juvenile Justice Act.

During the Jauljivi Mela, the District Legal Services Authority, Pithoragarh installed a stall from 14.11.2013 to 20.11.2013 at the mela premises. A total 606 people visited the stall. Information on programmes/activities of the Legal Services Authorities, Mediation, Lok Adalat and the provisions pertaining to Motor Vehicle Act, Domestic Violence Act, Child Labour Act, Juvenile Justice Act, Right to Education, Right to Information, Revenue Laws, PC&PNDT Act and Forest Act was given to the visitors. 6000 Saral Kanooni Gyan Mala booklets having basic legal information and pamphlets prepared by Uttarakhand State Legal Services Authority were given to the visitors. Beside this, 24



applications of disaster victims, 13 applications for issuance of income certificate, permanent resident certificate, ration card and 11 applications for providing houses were received. The said applications were forwarded to the concerned departments for appropriate action.

District Legal Services Authority, Pithoragarh organized a legal literacy and sensitization camp on 8.12.2013 at Government Degree College, Narayan Nagar, Didihat. In the said camp, Medical Department, Revenue Department, Horticulture Department, Social Welfare Department, Forest Department and Agriculture Department also put up their stalls. The gathering was provided basic legal information and they were also made aware about various welfare schemes of the State Government. A total 500 persons were benefited.

On 20.12.2013 District Legal Services Authority, Pithoragarh organized a legal literacy and sensitization camp at Judicial Lock-up, Pithoragarh wherein prisoners were informed about their legal rights and necessary legal aid was also provided to them. The procedure pertaining to arrest and bail and the provisions of criminal laws were also told to them.

District Legal Services Authority, Rudraprayag conducted a legal literacy and sensitization camp at Government Intermediate College, Ratura on 27.10.2013. In the said camp, 200 persons were

present. Information pertaining to provisions of Right to Information, Right to Education and Labour Laws was given.

On 17.11.2013 District Legal Services Authority, Rudraprayag conducted a special camp for children. In the said camp students were informed about their legal rights, Right to Education Act as well as about Children Day. A total 746 students were benefited.

District Legal Services Authority held a legal literacy and sensitization camp on 8.12.2013 at Government Girls Inter College, Rudraprayag wherein students were told about the provisions relating to Right to Information, Revenue Laws and the functions of Legal Services Authorities in the State.

On 9.11.2013, District Legal Services Authority, Tehri Garhwal organized a legal literacy camp on the issues pertaining to PC&PNDT Act at the premises of office of Block Development Officer, Kirtinagar. In the said camp, Judicial Officers, Advocates, Doctors, ASHA workers and staff of Medical Department were present. People were sensitized of the provisions relating to PC&PNDTAct. A total number of 200 persons were benefited.

District Legal Services Authority, Tehri Garhwal conducted a special camp for women at Sant Nirankari Satsang Bhawan, Baurari on 10.11.2013 wherein gathering were informed about women rights, compensation to senior citizen, provisions relating to Protection of Women from Domestic Violence Act and the free legal aid being provided by the Legal Services Authorities. A total 335 persons were benefited.





On 17.11.2013 District Legal Services Authority, Udham Singh Nagar conducted a legal literacy and sensitization camp at Government Intermediate College, Dineshpur wherein students were apprised of the general laws and health issues. In the said camp, 250 students were benefited.

District Legal Services Authority, Udham Singh Nagar conducted a legal literacy and sensitization camp at Government Intermediate College at Kashish Hall, Kashipur on 24.11.2013 wherein people were apprised of the laws pertaining to day to day importance. In the said camp, 350 persons were benefited.

On 22.12.2013 District Legal Services Authority, Udham Singh Nagar organized a legal awareness-cum-medical camp at Government Inter College, Mahuwa Dabra, Jaspur. In the said camp 300 persons were present. They were apprised about the objects for conducting the legal literacy and sensitization camps as well as about the programmes and activities being run by the Legal Services Authorities in the State. Free check-ups were also made in the said camp.

On the occasion of 'World Mental Health Day', District Legal Services Authority, Uttarkashi conducted a special legal literacy seminar at District Court Compound, Uttarkashi on 10.10.2013. The gathering was informed about the provisions of Mental Health Act, 1987. Focus was also made to protect the rights of the mentally ill persons and to provide them proper medical facilities.

On 27.10.2013 District Legal Services Authority, Uttarkashi organized a legal literacy and sensitization camp at Government Intermediate College, Pipli Dhanari. The purpose for organizing awareness camps was explained to the people. Information on various legal subjects, such as Motor Accident, Right to Information, Domestic Violence, Consumers, Revenue, Rights of Women and Children was also given. In the said camp, the officers of district administration were also present. They told the people about the schemes being run by the State Government for their welfare. The Medical Department also conducted health check-up and medicines were also distributed to the patients. 2000 people were benefited in the said camp.

On 14.11.2013 and 17.11.2013 District Legal Services Authority, Uttarkashi conducted legal literacy camps at Government Kirti Inter College and at Goswami Ganesh Dutt Inter College respectively. In these camps, gathering was informed about various subjects of law pertaining to Child Marriage, F.I.R., Motor Accident, Compensation, Right to Information, Consumers. A total 580 persons were benefited.

LEGAL AWARENESS CAMPAIGN THROUGH MOBILE VAN

In order to provide legal aid and advice at the doorsteps, legal awareness and sensitization camps are being organized through mobile van. The mobile van visited 10 villages of District-Champawat from 18.11.2013 to 22.11.2013.

Similarly, from 16.12.2013 to 19.12.2013 legal awareness and sensitization camps were conducted in 19 villages of District-Udham Singh Nagar. In the said camps documentary films on the subjects of mediation, lok adalat and legal aid prepared by National Legal Services Authority and State Legal Services Authority were displayed so as to make the public aware about their legal rights and duties. Also various legal provisions of social importance were also informed to the people. The gueries raised by the villagers were also solved in these legal awareness and sensitization camps.

In these camps, a total number of 6397 persons were benefitted. The applications were also received for legal aid which were either disposed of at the level of State Authority or were sent to the authorities concerned for appropriate and necessary action.
