INAUGURATION OF ADR BUILDING IN UDHAM SINGH NAGAR

In order to sensitize the people about ADR mechanism as well as to facilitate the mediation activities, lok adalats and legal aid & advice under one roof, the building of ADR Centre at District Court, Udham Singh Nagar, constructed from the funds received under 13th Finance Commission, was inaugurated on 14.3.2014 by the kind hands of Hon'ble Mr. Justice Barin Ghosh, Chief Justice/Patron-

in-Chief, Uttarakhand State Legal Services Authority, Hon'ble Mr. Justice B.S. Verma, Executive Chairman, Uttarakhand State Legal Services Authority and Hon'ble Mr. Justice Alok Singh, Administrative Judge, District-Udham Singh Nagar in the presence of Sh. D.P. Gairola, Registrar General, High Court of Uttarakand, Sh. Pradeep Pant, Member Secretary, Uttarakhand State Legal Services Authority and Sh. R.C. Kukreti, District Judge, Udham Singh Nagar. This is the first A.D.R. Centre built up in the State of Uttarakhand.









SPECIAL LEGAL LITERACY PROGRAMME ON CRIME AGAINST WOMEN ||||||||

Uttarakhand State Legal Services Authority in association with Police Department conducted two Awareness Programmes on 19.3.2014 and 22.3.2014 for police personnel of Kumaon Region. The theme of the programme was 'Protecting Crimes Committed against Women - A Campaign'. During the occasion, 1050 police personnel were sensitized about protection of crimes against women. A total







number of 110 booklets of 'Saral Kanooni Gyan Mala' published by Uttarakhand State Legal Services Authority were distributed among the gathering and the documentary films titled 'Ghar Ki Baat', 'Hamari Awaaz', 'Bechari Nahi Hai Nari', 'Nav Prabhat' and 'Khel Mukadmebazi Ka' were also displayed.

SPECIAL LEGAL LITERACY DRIVE ON INTERNATIONAL WOMEN DAY

With view to celebrate the International Women Day, the District Legal Services Authority, Dehradun in association with Janjagaran Society organized a legal literacy and sensitization camp on 8.3.2014 at Government Girls Inter College, Rajpur Road, Dehradun. Need to provide education, security as well as respect to the female children was expressed. A painting competition on subjects domestic violence and save the female child was also organized.



Dalit Mahila Legal Helpline in coordination with District Legal Services Authority, Dehradun organized a workshop on Free Legal Skill

Development from 7.3.2014 to 11.3.2014. In the said workshops, senior panel lawyers, representatives of Dalit Mahila Legal Helpline, members of local bodies, social servants and Aanganbadi workers were present. Nukkad Natak and documentary film 'Sanvidhan Ka Nirmaan' was displayed to the women of marginalized society. The gathering was informed about women rights and the provisions pertaining to Protection of Women from Domestic Violence Act, Right to Information Act, Sexual Harassment at Workplace Act. A total 400 female participants were benefited.

Special programme was organized by District Legal Services Authority, Pithoragarh on 8.4.2014 at Community Health Centre, Didihat wherein people were informed about women rights and provisions relating to violence against women.





LEGAL AWARENESS CAMPAIGN THROUGH MOBILE VAN

During the months of January, 2014 to March, 2014, the mobile van visited 83 villages of District-Almora, Dehradun and Hardwar. In the said camps, people were sensitized about legal provisions of social importance. Documentary films on the subjects of mediation, lok adalat and legal aid prepared by National Legal Services Authority and State Legal Services Authority were displayed. The queries raised by the villagers were also solved in these legal awareness and sensitization camps.











In these camps, a total number of 6943 persons were benefitted. The applications were also received for legal aid which were either disposed of at the level of State Authority or were sent to the authorities concerned for appropriate and necessary action.

FULL TIME SECRETARIES IN STATE OF UTTARAKHAND

The Government of Uttarakhand vide G.O. No. 396(1)/XXXVI(1)/2014-184/2001 T.C. dated 24.2.2014 has created 13 posts of Full Time Secretary along with 13 posts of Accounts Clerk and Stenographer for all 13 District Legal Services Authorities of the State.

ESTABLISHMENT OF VILLAGE LEGAL CARE AND SUPPORT CENTRES

During the occasion of inauguration of Nationwide Village Legal Care and Support Centres throughout the country, 44 Village Legal Care and Support Centres were established in various tehsils of State of Uttarakhand on 24.1.2014. Thereafter during the months February and March, 2014, 13 more Village Legal Care and Support Centres were established. 57 Panel Lawyers and 114 Para Legal Volunteers were also selected for strengthening the legal awareness/legal services mechanism in the State.

Training of Para Legal Volunteers is completed in 7 districts of the State and is underway in the remaining 6 districts. After completion of training of Para Legal Volunteers, their services will be utilized for wide publicity of the legal services programmes/schemes and for providing the necessary legal aid to the maximum number of needy people.













VIDEO CONFERENCE SESSION

Member Secretary, Uttarakhand State Legal Services Authority held a video conference session through NIC with all the Secretaries, District Legal Services Authorities on 15.2.2014. In the said session, discussion was made on effective implementation of various schemes of National Legal Services Authority and for establishment of Village Legal Care & Support Centres as well as training of Para Legal Volunteers.

ACTIVITY ON LEGAL LITERACY AND AWARENESS

On the occasion of induction training programmes of Transport Tax Officers and Food & Supply Inspectors, the Member Secretary, Uttarakhand State Legal Services Authority had delivered talks on the subject 'Legal Awareness and Legal Aid' on 30.1.2014 and 5.2.2014 at Uttarakhand Academy of Administration, Nainital. Saral Kanooni Gyan Mala booklets published by Uttarakhand State Legal Services Authority were distributed and the newly entrant officers were informed about the role and importance of legal services institutions.







LEGAL AWARENESS CAMPS AT JAILS IN UTTARAKHAND

District Legal Services Authority, Pithoragarh conducted legal awareness and sensitization programmes at judicial lock-up on 16.1.2014, 18.2.2014 and 31.3.2014 wherein prisoners were sensitized about their legal rights and the free legal aid available to them. They were also apprised of the procedures relating to arrest, bail, remand, Cr.PC. and IPC.





LOK ADALATS & LEGAL LITERACY/LEGAL AID CAMPS

Under the valuable guidance of Hon'ble the Patron-in-Chief and Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority, Mega Lok Adalats as well as monthly Lok Adalats are being organized in all the 13 districts of the State, under the aegis of all the District Legal Services Authorities.

In the Lok Adalats held in the months of January, February and March 2014 in all the 13 districts, a total number of 4764 cases were taken up and 1751 cases were settled. A sum of `21,12,978.00 was awarded as compensation and a fine to the tune of `18,42,912.00 was realized. In the said Lok Adalats, 1802 persons were benefited.

In addition to this, a total number of 40 legal literacy camps were organized in all the 13 Districts of the State during January to March 2014 and 13094 persons were benefited in the said camps. Total 125 persons were provided legal aid and 19 persons were given legal advice. In these camps, people were made aware about the aim of legal literacy camps, free legal aid and they were also informed about the general laws such as criminal law, revenue law, right to information act, right to education and law relating to protection of women, children etc.

LEGAL AWARENESS PROGRAMME AT DISTRICT LEVEL

District Legal Services Authority, Almora conducted a legal literacy and sensitization camp from 2.3.2014 and 8.3.2014 at Tehsil-Bhikiasain and Government Inter College, Lamgada. In the said camp, 900 persons were benefited. They were provided information pertaining to Forest Laws and Revenue Laws. They were also informed about the welfare schemes being run by the State Government.

On the occasion of Uttarayani Mela, District Legal Services Authority, Bageshwar put up a stall from 13.1.2014 to 17.1.2014 at



Ramleela Ground, Numais Khet. A large number of people visited the stall and got information on various subjects of laws, such as Motor Vehicle Act, PC&PNDT Act, Child Laws and Narcotic Act. They were also informed about the objects and activities of legal services institutions, lok adalat and entitlement of free legal aid. In the said camp, 2800 persons were benefited.

In order to aware the people of remote areas about their legal rights, the District Legal Services Authority, Bageshwar conducted a sensitization camp on 23.3.2014 at Nauling temple, Kidai village. The villagers were informed about the provisions pertaining to Gambling Act, Excise Act, Motor Vehicle Act, Forest Act, MNREGS, Forest Act, Narcotics Act and the subjects relating to Child Marriage and Compensation. A total number of 150 persons were benefited.





District Legal Services Authority, Chamoli conducted a legal literacy/medical camp on 23.2.2013 at Government Intermediate College, Gauchar wherein people were informed about the objects and the free legal aid being provided by the legal services authorities. Gathering was also informed about various provisions pertaining to Dowry, Wildlife, Compensation, Child Rights and PC&PNDT. Concern was also made on sex determination, female foeticide etc.

On 18.1.2014, District Legal Services Authority, Champawat organized a legal literacy and awareness camp for female students at Poornagiri Inter College, Bhajanpur wherein students were informed about protection from sexual harassment and their self defence. 375 students were benefited.

On 23.2.2014 District Legal Services Authority, Champawat conducted a legal awareness-cum-medical camp at Government Inter College, Amori. In the said camp, people were sensitized about their legal rights and the general provisions of law. Free





checkups of patients was done and the medicines were also distributed. The necessary certificates were also issued to the needy people.

District Legal Services Authority, Champawat organized a sensitization camp on A.D.R. wherein Judicial Officers, Superintendent of Police, Advocates, Branch Manager, S.B.I. and A.R.T.O., Tanakpur were present. The gathering was made aware about the Alternative Dispute Redressal mechanism. The benefits of mediation were also told to them.

On 8.3.2014, District Legal Services Authority, Champawat conducted a legal literacy-cummedical camp at Government Inter College, Digalichaud. Importance on legal informative materials contained in 'Saral Kanooni Gyan Mala' booklets was expressed.





People were also asked to get benefited by attending the legal literacy camps organized by legal services institutions. People were also medically examined and distributed medicines free of cost. A total 1220 persons were benefited in this camp.

District Legal Services Authority, Haridwar conducted legal awareness camps at Kewal Kanya Inter College, Mangalore and Government Inter College, Abdul Rahimpur wherein students were made aware about lok adalat, mediation, right to information act, free legal aid, child labour and women rights. A total 410 students were benefited.

On 12.3.2014 District Legal Services Authority, Nainital conducted a seminar on 'Domestic Violence' at Tallital Dharmshala. Women were apprised of their legal rights, procedure for lodging F.I.R. against domestic violence and harassment. Need on women empowerment was also expressed.

The information on various subjects of law was provided to the gathering. The people were also made aware of various welfare schemes run by State Government and permanent residence certificates, income certificates and caste certificates were also given to the people. In the said camp, judicial officers, advocate, members of bar association, doctors, and officers of district administration. 300 persons were benefited in the said camp. (newspaper cutting 5)
