LEGAL LITERACY AND AWARENESS DRIVE AT STATE LEVEL

In order to propagate legal awareness and to make the people aware about the legal aid services and activities being run by the legal services institutions, the Uttarakhand State Legal Services Authority put up a stall during the 'Harela Fair' at Bhimtal, District-Nainital from 16.7.2015 to 20.7.2015. The Member Secretary as well as Officer on Special Duty, Uttarakhand State Legal Services Authority sensitised the common people about the schemes and activities of legal services institutions. 293 persons visited the stall and got benefited. A total 5,660 booklets of Saral Kanooni Gyan Mala series along with pamphlets and brochures were also distributed to the people.
