It is kindly submitted that in compliance of the direction of Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority, Nainital, mass legal literacy and awareness programmes and camps were organized in six districts of the State of Uttarakhand through Mobile Van of the Uttarakhand State Legal Services Authority, Nainital from 23rd September, 2024 to 28th September, 2024 and from 16th October, 2024 to 21st October, 2024.

For this purpose, an approved schedule of the Mobile Van Awareness Drive was circulated by the Uttarakhand State Legal Services Authority, Nainital to the following districts:-

In order to ensure the effective implementation of the aforesaid Awareness Drive through Mobile Van, following directions were issued to the aforesaid Districts:-

- Concerned DLSAs are directed to display/broadcast the documentary films and other audio-video informative materials (as prepared by the NALSA, New Delhi and Uttarakhand SLSA, Nainital) to the general public during the mobile van visit.
- 2. Concerned DLSAs are directed to distribute the Saral Kannuni Gyan Mala Books and other legal awareness literature to the general public.
- 3. Necessary applications, forms, etc. for seeking legal aid, advice, and other beneficial schemes of the Central/State Government shall be filled up/prepared by the PLVs on the spot and thereafter the office of DLSA shall coordinate with the concerned departments.
- **4.** Concerned DLSAs are directed to deploy 02 PLVs for each day with the Mobile Van for this purpose.
- **5.** Concerned DLSAs are directed to avail the services of Panel Lawyers for this purpose.
- 6. Concerned DLSAs are directed to coordinate with the Police, District & School Administration and the concerned Gram Panchayats and Gram Pradhans, etc. for extending their cooperation in this regard.

In compliance of the aforesaid directions, concerned District Legal Services Authorities conducted mass legal literacy and awareness programmes and camps through Mobile Van in rural and urban areas of their districts as well as in schools and Colleges.

On the basis of the statistical information furnished by the aforementioned District Legal Services Authorities relating to the said Mobile Van Drive, a consolidated report has been prepared and the same is hereunder:-

It is kindly submitted that as per the District-wise reports mentioned in the above table, it is found that during the aforesaid Mobile Van Awareness Drive, total 123 legal awareness programmes/camps organized in urban and rural areas including schools and colleges wherein around 43120 persons and students attended these legal awareness programmes/camps. Further, it is kindly submitted that total 43444 (approx.) persons were benefitted by this Mobile Van Awareness Drive.

During the aforesaid Mobile Van Awareness Drive, public made aware about the working and functions of NALSA, SLSA, DLSA, various schemes and policies of NALSA, Victim Compensation Scheme, Anti Drug Campaign, Human Rights, Women Rights, Traffic Rule, Road Safety, Cyber Crime and harassment, POCSO Act, Lok Adalat, Mediation and Conciliation, Forest Laws, Rules made for the protection of Animals, Welfare schemes for soldiers/ex-servicemen and their families, Child Labour, Legal knowledge about sale and purchase of land in Uttarakhand State, Succession certificate, Juvenile Justice Act, Female Feticide, NALSA Helpline No. 15100, Commercial Courts, other important Laws and Acts, etc.
