**FOR THE POST OF PROJECT CONSULTANT**

- 1. Disqualification for appointment**:- A person shall not be eligible for appointment:-
  - (a) if he is not a citizen of India;
  - (b) if he has been convicted of an offence involving moral turpitude or he is or has been permanently debarred or disqualified by the Union Public Service Commission or any State Public Service Commission from appearing for examinations or selections conducted by it;
  - (c) if he directly or indirectly influences the 'Selection Committee' by any means for his candidature.
  - (d) if he has more than one spouse or married to such a person who already has a living legally wedded wife/husband.
  - (e) if he is involved in any kind of criminal case whether convicted or charge sheeted.
- 2. Condition relating to suitability, fitness and character**:- No person recommended for selection by the Selection Committee shall be appointed:-
  - (I) unless the Appointing Authority is satisfied that he is of good character and is in all respects suitable for appointment to the service;
  - (II) unless he is certified by the government medical authority that he is medically fit to discharge the duties of the post for which he is selected.
- 3. Other Conditions of Engagement**: The Project Consultant shall be governed by such rules of attendance, leave and other service related matters as applicable to the Uttarakhand SLISA.
