

**NOTE:**

1. This order will come into force with immediate effect and all the abovementioned Chairmen and Members, Permanent Lok Adalats shall take over charge of their posting on or before 6<sup>th</sup> November, 2017 in their respective districts.

Before joining, the abovementioned Members, Permanent Lok Adalats shall have to give an undertaking before respective District Judge/Chairman, District Legal Services Authority that he/she does not and will not have any such financial or other interest as is likely to affect prejudicially his functions as such Members.
